DIRECTIONS

CAMP USE:

Call Denny. If you'd like to go to Kilkenny Valley, notify Dennis at 530-795-5227 (hodit7@gmail.com). He can advise you of:

- Who else is planning to use the property at the same time,
- Any special supplies that need to be taken,
- Road and camp conditions,
- Chores that you can perform, and
- Pending repairs or improvements.

Remove Your Trash. While in camp, please follow all the camp rules, and most importantly, take all your trash out with you. "Trash" is not just garbage; it is whatever you bring into camp.

One Hour of Chores. The corporation adopted a policy asking all campers between the ages of 8 and 80 to perform one hour of chores for each stay. Please note the chores you have performed in the log.

Non-Member Guests. The corporation asks for voluntary contributions from non-member guests. All campers must sign the waiver of liability statement, which is typically found near or within the camp log. Remember - non-family members are only allowed in camp when accompanied by a family member.

Gas and Wood. Be considerate of the next visitor. Bring your own gas and cut your own wood.

Indemnity. Ask all visitors (members and guests) to sign the indemnity located below the bulletin board.
